### SUMMARY

The Office of Biological and Environmental Research (BER) of the Office of Science (SC), U.S. Department of Energy (DOE) hereby announces its interest in receiving applications for research in Environmental Systems Science (ESS), including Terrestrial Ecosystem Science (TES) and Subsurface Biogeochemical Research (SBR). The mission of the Climate and Environmental Sciences Division (CESD) within BER is to advance a robust predictive understanding of Earth's climate and environmental systems and to inform the development of sustainable solutions to the Nation's energy and environmental challenges.

The goal of the Environmental System Science (ESS) activity in the Office of Biological and Environmental Research (BER) is to advance a robust predictive understanding of terrestrial environments, extending from bedrock to the top of the vegetated canopy and from molecular to global scales in support of DOE's energy and environmental missions. Using an iterative approach to model-driven experimentation and observation, interdisciplinary teams of scientists work to unravel the coupled physical, chemical and biological processes that control the structure and functioning of terrestrial ecosystems across vast spatial and temporal scales. State-of-science

understanding is captured in conceptual theories and models which can be translated into a hierarchy of computational components and used to predict the system response to perturbations caused, for example, by changes in climate, land use/cover or contaminant loading. Basic understanding of the system structure and function is advanced through this iterative cycle of experimentation and observation by targeting key system components and processes that are suspected to most limit the predictive skill of the models.

This FOA will consider applications that focus on measurements, experiments, modeling or synthesis to provide improved quantitative and predictive understanding of terrestrial ecosystem and/or subsurface processes that can affect the cycling and transport of carbon, water, nutrients, and contaminants. All projects are required to clearly delineate an integrative, hypothesis-driven approach and clearly describe the existing needs/gaps in state-of-the-art models. Applicants should provide details on how the results of the proposed research, if successful, will be incorporated into numerical models of subsurface systems and/or terrestrial ecosystems.

## **SUPPLEMENTARY INFORMATION**

This FOA will accept traditional, “full” applications with requested support for up to three years, which addresses a research need within scope of the program objectives indicated in this FOA. In addition, BER also encourages the submission of smaller, more focused and innovative research that would be perceived as “high-risk” applications which may have the potential for future high impact on environmental system science. These innovative applications are encouraged where the proposed research is intended to fill critical knowledge gaps, including the exploration of high-risk approaches. The probability of success and the risk-reward balance will be considered when making funding decisions.

### **Program Objectives**

While the Environmental System Science activity supports a broad spectrum of fundamental research in terrestrial ecosystem and subsurface biogeochemical science, this FOA will only consider research applications within this scope in the following science areas:

#### **1. Terrestrial Ecosystem Science (TES) Areas of Focus**

The TES program seeks to develop unique, foundational scientific insights about the terrestrial biosphere’s role in the global cycling of carbon, nutrients, and water. The program also supports research examining the feedbacks between the terrestrial biosphere and Earth’s climate system. TES focuses on ecosystems and ecological processes that are globally or regionally significant, expected to be sensitive to climate change, and insufficiently understood or inadequately represented in models. The scope of the program includes measurements, experiments, modeling and synthesis to provide improved quantitative and predictive understanding of terrestrial ecosystems in the context of a changing climate.

For this FOA, TES seeks research applications that improve our ability to understand and predict the role of unmanaged terrestrial ecosystems in a changing climate. Furthermore, proposed research projects should complement, not duplicate, TES’s current research

investments. Applicants are encouraged to consider utilization or collaboration with sites that have existing support (see Specialized Resources below) thereby leveraging ongoing infrastructure and investments, archived samples and long-term data sets.

Applications should demonstrate a systems approach to understand ecosystems over the multiple temporal and spatial scales that are represented in models (e.g., single process models, ecosystem models, and global models). This emphasis on the capture of advanced understanding in models has two goals. First, it seeks to improve the representation of these processes in coupled models, thereby increasing the sophistication and confidence of the projections produced by those models. Second, it encourages the community to understand and use existing models and to compare model results against observations or other data sets to inform future research directions. It also seeks to encourage an iterative dialog between the process and modeling research communities such that research objectives are designed to address model gaps and weaknesses, and that modeling efforts are designed to inform process research (i.e., the model-experiment (ModEx) integration approach).

All projects (including synthesis activities) should clearly delineate an integrative, hypothesis-driven approach and clearly describe the existing needs/gaps in state of the art models. Applicants are required to employ a model-inspired approach to pose their research questions, which in turn provides a direct link to improving the model or process representation at the appropriate scales. Applicants should argue how the results of the proposed research, if successful, will improve our ability to understand and predict the role of the terrestrial ecosystems in a changing climate. However, the proposed project does not need to include a modeling component, but it must have a well-described modeling context.

Given extensive efforts by DOE to develop the new Accelerated Climate Model for Energy (ACME) (<http://climatemodeling.science.energy.gov/projects/accelerated-climate-modeling-energy>) and Earth system model components such as the Community Land Model (CLM), applicants are encouraged to link their activities to these efforts where appropriate. In addition, in 2012 the Climate and Environmental Science Division released its strategic plan that outlined science needs for basic research in climate science, including terrestrial ecosystem science (<http://science.energy.gov/~media/ber/pdf/CESD-StratPlan-2012.pdf>). Applicants are also encouraged to review this strategic plan to familiarize themselves with the identified science needs.

For this FOA, applications that address the following areas of focus are requested:

- Science Area 1 – Belowground Processes: The role of belowground processes and mechanisms associated with a changing climate at ecologically relevant temporal and spatial scales;

- Processes and mechanisms for the mediation and transformation, mineralization, and stability of carbon in soils (e.g., including microbial cycling, mineral-organic interactions, soil organic matter accessibility); and/or
  - Plant-Microbe-Soil interactions (e.g., mycorrhizal interactions; rhizodeposition) that mediate carbon flux and can extend to ecosystem carbon balance.
- Science Area 2 – Critical Ecosystems: New or improved understanding of biogeochemical pathways (e.g., N and/or P) that mediate carbon feedbacks and ecosystem function in:
    - Process and mechanisms that mediate carbon relevant biogeochemical processes in Arctic (including high latitude boreal forest) ecosystems; and/or
    - Processes and mechanisms that mediate key climate feedbacks of tropical forests

### *Belowground Processes*

Belowground processes are a critical component to carbon and associated biogeochemical cycling, yet these processes are currently over-simplified or ignored in most large-scale models. Applications focusing on belowground ecosystem processes should seek to quantify rates and magnitudes of carbon accretion and foundational biogeochemistry related to climate change. Additionally, applications focusing in this area should seek to understand processes and properties that control transformation of biomass into organic matter, including studies of stabilization mechanisms of the long residence time components, their accessibility, fate, and ecosystem feedbacks. Research is needed on these processes for different climate and vegetation conditions where results can be spatially scaled to estimate carbon changes across climate zones and bioregions. Products of research that focus on belowground carbon processes that mediate carbon dynamics (e.g., organic matter stabilization and dynamics, carbon turnover rates, microbial and mycorrhizal interactions, carbon/nitrogen/other relationships) should provide new insights and model representations for coupled interactions, residence time and other carbon source or sink properties of belowground ecosystem components. Research that focuses on inorganic biogeochemical/contaminant fate and transport will not be considered for this research area.

### *Critical Ecosystems*

#### Carbon relevant biogeochemical processes in terrestrial Arctic ecosystems

Arctic tundra and adjacent high-latitude boreal forests represents a vast expanse of northern land mass. Permafrost in this area represents one of the largest volumes of carbon stored in the biosphere. Permafrost thaw, resulting from a warming climate is expected to release CO<sub>2</sub> and CH<sub>4</sub> into the atmosphere as the formerly frozen organic material becomes vulnerable to decomposition. The nature and rates of these releases are poorly understood and thus are inadequately represented in Earth system models. Applications are sought for fundamental research to advance our understanding of the function of widespread, critical northern terrestrial ecosystems, particularly in ways that



influence biogeochemical feedbacks to the climate system. Of particular emphasis are studies targeting vegetation dynamics and hydrology (alone and their interactions) in areas of continuous and discontinuous permafrost. Successful applications will link measurements and/or experiments to modeling needs or omissions to provide improved quantitative and predictive understanding of the coupled biological, chemical, and physical interactions that represent potentially strong carbon cycle feedbacks to climate. Applicants in this area are encouraged to be aware of, and consider collaborations with the NGEE-Arctic project (for additional information see Specialized Resources below)

#### Mediation of key climate feedbacks in tropical forested ecosystem

The tropics include approximately 40% of Earth's land surface area and critically regulate many Earth system processes. Mesic tropical terrestrial ecosystems represent a major reservoir of terrestrial carbon and cycle more carbon dioxide and water than other biomes, thus playing important roles in determining Earth's energy balance, which drives global systems of temperature and precipitation. Tropical ecosystems are expected to experience significant stress under a changing climate and represent a critical global system that is poorly understood. This lack of understanding results in corresponding limitations to the representation of these systems in ecosystem and global-scale carbon cycle and climate system models, thereby limiting the ability of those models to confidently project future conditions. Important questions from microscale (microbial processes, biogeochemical processes) to macroscale (plants and plant systems, watersheds) to landscape (and global) scale remain unanswered regarding carbon dynamics in tropical systems. Applicants in this area are encouraged to be aware of, and consider collaborations with the NGEE-Tropics project (for additional information see Specialized Resources below). The 2012 report, "Research Priorities for Tropical Ecosystem Under Climate Change" ([http://science.energy.gov/~media/ber/pdf/NGEE-Tropics\\_LR.pdf](http://science.energy.gov/~media/ber/pdf/NGEE-Tropics_LR.pdf)), outlines key model uncertainties in tropical ecosystems.

#### *Other*

Applications that include the collection of flux measurements for carbon, water and/or energy must contribute to the AmeriFlux Network (<http://ameriflux.lbl.gov/>). The establishment of new carbon flux measurement locations will be balanced carefully against the value of existing sites. Potential applicants are encouraged to review scientific activity and data associated with the existing AmeriFlux locations and to consider opportunities for collaboration as alternatives to the establishment of new sites. For applications that seek to sustain existing AmeriFlux locations, priority will be placed on hypothesis-based research and sites that have a strong record of measurement performance and prompt delivery of data products to the AmeriFlux archive for use by the broader scientific community. There is an established archive for reporting AmeriFlux data (<http://ameriflux.lbl.gov/Data/Pages/How-to-Upload-or-Download-Data.aspx>), and supported projects will be expected to comply rigorously with reporting guidelines and standards.

Research applications focusing on the topics above should consider utilization of available data products (e.g., AmeriFlux (see link above) and FACE (<http://public.ornl.gov/face/>), NGEE-Arctic, etc.) where appropriate. Applications that require access to major computational assets (e.g., utilization of the Legacy Class Facilities at the National Laboratories) should describe how they would obtain the necessary access to conduct the proposed research.

DOE's Climate Change research is an integral component of the U.S. Global Change Research Program (USGCRP) (<http://www.globalchange.gov/>), which is closely coordinated with other Federal carbon cycle research through the Carbon Cycle Science Program (<http://www.carboncyclescience.gov/>). The website for the Carbon Cycle Science Program includes a "Relevant Documents" section that provides links to key documents outlining science needs for U.S. carbon science research programs. For example, applicants are encouraged to review key relevant documents including, e.g., "A U.S. Carbon Cycle Science Plan" (<https://www.carboncyclescience.us/USCarbonCycleSciencePlan-August2011>) with particular emphasis on Goals 1 and 3 in the context of terrestrial ecosystems and this FOA.

## 2. **Subsurface Biogeochemical Research (SBR) Areas of Focus**

The Subsurface Biogeochemical Research (SBR) program seeks to advance a robust predictive understanding of how watersheds function as complex hydrobiogeochemical systems and how these systems respond to perturbations caused by changes to climate, land use/cover and contaminant loading. SBR researchers are encouraged to use a systems approach to probe the multiscale structure and functioning of watersheds and to capture this understanding in mechanistic models representing both the complexities of the terrestrial subsurface and ecohydrological interactions with surface water bodies and vegetation. A priority for the SBR program is to develop genome-enabled biogeochemical models of the multiscale structure and functioning of watersheds, which are key components of terrestrial environments. These mechanistic models, which extend from bedrock through soils to the vegetative canopy, are based on reactive transport codes which incorporate metabolic models of microbial processes; molecular-scale understanding of geochemical stability, speciation, and biogeochemical reaction kinetics; and diagnostic signatures of the system response at varying spatial and temporal scales. State-of-science understanding codified in models provides the basis for testing hypotheses, guiding experimental design, integrating scientific knowledge on multiple environmental systems into a common framework, and translating this information to support informed decision making and policies.

The SBR program sponsors three large field-based Scientific Focus Area (SFA) projects at the DOE National Laboratories, i.e., at the Pacific Northwest National Laboratory (PNNL) (<http://sbrsfa.pnnl.gov/>); Lawrence Berkeley National Laboratory (LBNL)

([http://esd.lbl.gov/research/projects/sustainable\\_systems/](http://esd.lbl.gov/research/projects/sustainable_systems/)); and Oak Ridge National Laboratory (ORNL) (<http://www.esd.ornl.gov/programs/rsfa/>). These large SFA's are investigating the influence of hydrologic processes on biogeochemical cycling within watersheds and river basins, including the impacts of groundwater-surface water interaction on nutrient elements (carbon and nitrogen) and the biogeochemical transformations of contaminants (uranium, technetium, and mercury). Within each SFA, long-term, team-research programs have been built around established field research sites in eastern and western river basins. The sites include a mountainous headwater catchment in the semi-arid Upper Colorado River Basin (LBNL SFA), a 75 km flood-plain reach of the Columbia River in the sparsely vegetated Columbia Plateau region (PNNL SFA), and the spring-derived East Fork Poplar Creek that flows into the Clinch River in humid Oak Ridge, TN (ORNL SFA). These projects also serve as modeling use cases in the IDEAS project (<http://ideas-productivity.org/>), which is aimed at improving scientific productivity and system level predictability using extreme-scale scientific computing. With coordination and community participation, the three SFAs offer significant potential for transforming our understanding of the role of interfaces in predicting hydrology-driven biogeochemical cycling, and in particular advancing understandings of groundwater-surface water interactions across a range of river basin characteristics.

The SBR program also sponsors three smaller SFA projects which focus on fundamental biogeochemical interactions extending from molecular to core scales, but which target critical processes of relevance at larger field scales, and which leverage unique DOE analytical capabilities at their respective national laboratories. The Argonne National Laboratory (ANL) SFA seeks to characterize coupled biotic-abiotic molecular-scale Fe, S, heavy metal, and radionuclide transformations, integrated over different length scales, to provide knowledge that is necessary for understanding subsurface processes and predicting contaminant reactivity and transport ([http://www.bio.anl.gov/environmental\\_biology/subsurface\\_science/doe\\_ober\\_sfa.html](http://www.bio.anl.gov/environmental_biology/subsurface_science/doe_ober_sfa.html)).

The SLAC National Accelerator Laboratory (SLAC) SFA seeks to investigate fundamental biogeochemical redox processes that control uranium and biogeochemical critical element behavior, with emphasis on hot spots of microbial and chemical activity in organic-rich fine-grained sediments (<http://ssrl.slac.stanford.edu/sfa/>).

The Lawrence Livermore National Laboratory (LLNL) SFA seeks to identify the dominant biogeochemical processes and the underlying mechanisms that control actinide transport (focusing on Pu and Np) in an effort to reliably predict and control the cycling and mobility of actinides in the subsurface (<https://seaborg.llnl.gov/research-environmental-radiochemistry.php>).

For this FOA, the SBR program is seeking research applications on topics that complement, but do not duplicate SBR's Science Focus Area program (SFA) investments. The contaminants of concern for this FOA are limited to U, Tc, Pu and Hg, which are major risk drivers at contaminated DOE sites and the primary focus of the SBR SFAs. Toward this aim, applications that address the following two science areas are

requested (the bullets represent potential topics that are complimentary to the current SBR SFAs):

- Science Area 3 – Hydrobiogeochemistry and Ecohydrology
  - Methodologies for quantitative measurements of exchange and flux rates (water and solutes) from the groundwater-surface water interaction zone at the local, reach, and watershed scales.
  - Ecohydrological studies that enable tracking the fluxes, stocks, and transformations of key constituents that control the speciation, distribution, and bioavailability of inorganic elements, including oxygen, nutrients, particulates, and dissolved organic matter to enable systems-level understanding of groundwater/surface water/vegetation interactions.
  - Influence of plant-microbe-soil interactions on inorganic element cycling and transformation in the groundwater-surface water interaction zone.
  - Multi-scale, facies-based, hydro-biogeochemical models of the groundwater-surface water interaction zone.
  - Characterization and modeling of the spatial heterogeneity (physical, chemical and biologic) of subsurface, riverine/hyporheic, and terrestrial environments (including microbial community composition and function) and their impacts on groundwater-surface water exchange and biogeochemical reactive transport.
  - Mechanistically-based multiscale modeling of coupled hydrologic, geochemical and biological processes in compartments and for the system as a whole.
  
- Science Area 4 – Biogeochemistry
  - Understanding of coupled redox dynamics among Fe and S cycles and organic matter/mineral dynamics and their subsequent roles in carbon, contaminant, and nutrient cycling.
  - Investigation of the role of nitrogen species (e.g.,  $\text{NO}_3^-$ ,  $\text{NO}_2^-$ ,  $\text{N}_2\text{O}$ ) in effecting electron transfer to/from Fe-containing minerals (e.g., oxides and clays), and subsequent mineralization processes.
  - Structures and thermodynamics of model U(IV)-ligand complexes.
  - Contributions to multi-scale mechanistic/reactive transport modeling of molecular scale processes that control inorganic element cycles and contaminant transport. Processes of interest include homogeneous precipitation of inorganic contaminants; co-precipitation of inorganic contaminants with minerals; ternary organic and inorganic element/contaminant surface complexes; diffusion and advection processes of inorganic elements/contaminants; and colloidal transport of inorganic elements/contaminants. Interfaces with sharp redox gradients are of particular interest. Multi-scale models are sought that bridge molecular to pore to core to plot to field and to watershed length scales.
  - Characterization of microbial and molecular mechanisms (gene identity, proteins and their structure-function, and pathways of importance) of biogeochemical processes, including nutrient, N- and C- cycling, biogenic gas formation and contaminant transformations in the subsurface and in groundwater-surface water interaction zones.

- Controls on the import and export of inorganic elements (e.g., Hg) from cells, including molecular-level imaging and characterization of cell surface functional properties and receptors for binding; identification of the cellular transport pathways involved in the uptake of the element; molecular-level experimental characterization of the mechanisms involved in intracellular transformation of elements; and mechanistic modeling of inorganic element transfer across critical biotic and abiotic interfaces.
- Contributions to multi-scale mechanistic/reactive transport models of microbial interactions with inorganic elements/contaminants and mineral surfaces.

### *Other*

SBR supports multidisciplinary research programs at the DOE National Laboratories as well as a diverse portfolio of research projects led by university PIs. This programmatic approach recognizes that the National Laboratories are structured for conducting coordinated, team-oriented research in a manner that is distinct from, but complementary to, research conducted by financial assistance (10 CFR Part 605). SBR is interested in applications from universities and the private sector that complement the existing SFA research programs; such applications are expected to provide unique or innovative insights into the research challenges facing the SFAs. **All applicants to the SBR topics for this FOA must explain in both their pre-application and their full proposal how the proposed project complements yet does not duplicate research conducted by one or more of the SBR SFAs.** All applications are required to clearly delineate an integrative, hypothesis-driven approach and clearly describe the existing needs/gaps in state-of-the-art models. Field investigations do not have to be performed at DOE funded field sites but they must be performed at research sites within the continental US, and we encourage applicants to utilize existing resources such as Ameriflux sites and NSF funded Critical Zone Observatory sites as well as DOE funded field sites which are primarily managed by the SFAs. For all field projects, a letter of support must be provided in the full application from the lead PI responsible for the field site where the project will be conducted.

Argonne National Laboratory (Ken Kemner). The ANL SFA seeks to characterize coupled biotic-abiotic molecular-scale Fe, S, heavy metal, and radionuclide transformations, integrated over different length scales, to provide knowledge that is necessary for understanding subsurface processes and predicting contaminant reactivity and transport. Pacific Northwest National Laboratory (John Zachara). The PNNL SFA seeks to develop a predictive understanding of the groundwater-surface water interaction zone and its linkages with the water cycle that incorporates hydrologic impacts on fundamental biogeochemical and ecological processes into a multi-scale modeling framework that can be used to understand and predict system responses and feedbacks to natural or anthropogenic induced environmental changes. ### **Collaboration For ESS Applications**

Multi-disciplinary and inter-institutional collaborations are strongly encouraged. Collaboration could include institutions such as universities, industry, non-profit organizations, Federal Agencies, and Federally Funded Research and Development Centers (FFRDCs), which include the DOE National Laboratories. For collaborations involving the DOE National Laboratories, the efforts conducted by the collaborating National Laboratory must reflect specific and unique capabilities/expertise at the collaborating DOE National Laboratory. The DOE National Laboratory component of these financial collaborations will be limited to no more than 10% of total costs and should show clear scientific leadership from the submitting institution and reflect an appropriate level of effort from the DOE National Laboratory. DOE National Laboratory employees are not eligible to be a lead PI on this FOA. (Note that funding to the National Laboratory collaborator as part of successful applications will be executed through a separate funding mechanism. See Section III.A of this FOA for explanation.)

**All collaborative applications must include letters of agreement from each collaborator who would receive funding.** These letters should specify the contributions the collaborators intend to make if the application is accepted and funded. **Applications for multi-investigator**

**projects must present a management structure** for integrating collaborating investigators. Involvement of students and post-doctoral scientists is encouraged. **The lead submission must include all budgetary information for all funded Co-PIs.** Applications that do not include these required elements will be considered non-responsive and will be declined without review.

### **Data Sharing Policy**

Research data obtained through public funding are a public trust. As such, these data must be publicly accessible. To comply with the digital data management policy of the DOE's Office of Science and BER's requirements, **applications submitted in response to this FOA must include a Data Management Plan (DMP).** The minimum requirements for the DMP are set forth on the SC web page (<http://science.energy.gov/funding-opportunities/digital-data-management/>). The DMP applies to all stages of the digital data life cycle, including capture, analysis, sharing and preservation, and therefore includes data from extensive, long-term observations and experiments and from long-term model simulations of climate that would be costly to duplicate. Additionally, BER has defined the exclusive use period to be one year after the end of the data acquisition period for the proposed performance period of the award (<http://science.energy.gov/ber/funding-opportunities/digital-data-management/>). Requests to extend the length of the exclusive use period to beyond one year will be considered on a case-by-case basis; requests will be evaluated and approved or denied by an appropriate ESS program manager, based on clear justification and the extent of unique or extenuating circumstances. **Explicit data management and data sharing plans are required and should be included as Appendix 6, and will not count towards the page limitation. The description must include plans for sharing the data that are to be acquired in the course of the proposed research, particularly how the acquired data will be preserved, documented, and quality assured, and where it will be archived for access by others (including the long-term/permanent storage of the data).** Data of potentially broad use in climate change research and assessments should be archived, when possible, in data repositories for subsequent dissemination. Applicants are encouraged to consider the DOE-funded data repository at <http://cdiac.ornl.gov/datasubmission.html> for data storage as well as long-term, deep archiving. If data are to be archived at the researcher's home institution or in some other location, the application must describe how, where, and for how long the data will be documented and archived for access by others.

### **Availability of User Facilities and Other Specialized Resources**

DOE has responsibility for programs and facilities that offer unique and complementary resources that support research in terrestrial ecosystem science and subsurface biogeochemical research. Potential applicants are encouraged to consider use of these programs/facilities in developing their applications. **Where applicable, the application must provide a letter of support/access from site coordinators and/or management of user facilities or other specialized resources.**

This documentation should be in the form of a letter of agreement from the collaborating institution/project included with the application. Examples of available user facilities and other specialized resources include:

### AmeriFlux

The AmeriFlux Network gathers and shares long-term carbon, water and energy flux measurements and site metadata collected by a cohort of sites that span a spectrum of climate and ecosystems across the Americas. The AmeriFlux Network ensures the availability of the continuous, long-term ecosystem measurements necessary to build effective models and multisite syntheses, while maximizing insight through robust, site-specific, independent research programs. Information on the availability of long-term flux data and contact information of the Network and individual AmeriFlux sites is available at: <http://ameriflux.lbl.gov/>.

### Atmospheric Radiation Measurement (ARM) Climate Research Facility

The ARM Climate Research Facility (<http://arm.gov>), an Office of Science user facility, provides the climate research community with strategically located in situ and remote sensing observatories designed to improve the understanding and representation, in climate and earth system models, of clouds and aerosols as well as their interactions and coupling with the Earth's surface. ARM operates three fixed sites: the Southern Great Plains (SGP) in Oklahoma; the North Slope of Alaska (NSA) in Barrow, AK; and the Eastern North Atlantic (ENA) in the Azores. ARM also has three mobile facilities (<http://www.arm.gov/sites/amf>), one of which is on an extended deployment to Oliktok Point, AK. All ARM data is available at no cost to scientific users through the ARM archive (<http://www.archive.arm.gov>). Deployment of the ARM Mobile Facility or ARM Aerial Facility to a specific location or large campaigns at fixed ARM sites is requested through an ARM facility user proposal process, with pre-applications due once a year. Smaller campaigns (such as deployment of user-owned instruments to ARM facilities or requests for intensive or special operation of existing ARM instruments) may be requested throughout the year. ### Environmental Molecular Sciences Laboratory (EMSL)

The Environmental Molecular Sciences Laboratory (EMSL) (<http://www.emsl.pnl.gov/>), an Office of Science user facility located at the Pacific Northwest National Laboratory (PNNL), leads molecular-level discoveries that translate into predictive understanding and accelerated solutions for DOE's and BER's environmental and energy challenges. EMSL provides users with a wide variety of premier experimental capabilities, production computing hardware and optimized software for molecular research. These capabilities enable users to iterate between simulation and experimentation to unravel the fundamental physical, chemical and biological processes that underpin climate, energy and environmental challenges. Experimental and computational capabilities include, e.g., dynamic imaging of metabolic processes; in situ imaging of atomic and molecular



reactions; molecular dynamics and reactive transport modeling; proteomics and metabolomics; surface science and elemental analyses; and quantification of the flow and transport of natural and anthropogenic materials in flow cells. These capabilities are available at no charge through a user proposal process (see: <https://www.emsl.pnl.gov/emslweb/working-us>).

### High Performance Computing Centers

DOE supports several high performance and leadership computing centers, which provide compute cycles and data storage through a proposal process to the scientific user community. These resources include:

- the hardware, calibrated codes, and data storage capabilities for BER-supported scientists within the Molecular Science Computing (MSC) capability at EMSL (<http://www.emsl.pnl.gov/capabilities/computing/>),
- the hardware and data storage capabilities at several other Office of Science user facilities. These include the National Energy Research Scientific Computing Center (NERSC) at the Lawrence Berkeley National Laboratory (<http://www.nersc.gov>), the Oak Ridge Leadership Computing Facility (OLCF) at Oak Ridge National Laboratory (<http://science.energy.gov/ascr/facilities/user-facilities/olcf/>), and the Argonne Leadership Computing Facility (ALCF) at Argonne National Laboratory (<http://science.energy.gov/ascr/facilities/user-facilities/alc/>). Access to these hardware systems and data storage capabilities are available through several processes, as described on the DOE Office of Advanced Scientific Computing Research (ASCR) web site (<http://science.energy.gov/ascr/facilities/accessing-ascr-facilities/>).

Opportunities to submit proposals for time allocations include the INCITE (Innovative and Novel Computation Impact on Theory and Experiment), ALCC (ASCR Leadership Computing Challenge), ERCAP (Energy Research Computing Allocations Process), and the NERSC and LCF Center Reserves processes.

### Joint Genome Institute

The Joint Genome Institute (JGI) in Walnut Creek, California, an Office of Science user facility, provides the scientific community access to state of the art genomic sequencing and analysis capabilities, as well as modest amounts of DNA synthesis capability, for microbial, plant, microbial community, and other (non-pathogen) targets. In all cases, the aim of the JGI is to provide to the national and international scientific community information on the genome-derived “parts lists” that support further discovery (<http://www.jgi.doe.gov>). These resources are available at no charge through a user proposal process (see <http://proposals.jgi-psf.org/>).

### Neutron Beam Facilities

DOE provides the scientific community access to high flux neutron sources that are capable of providing structural and chemical information often unavailable using other technologies. DOE has two such Office of Science user facilities at the Oak Ridge

National Laboratory, the Spallation Neutron Source (SNS; <http://neutrons.ornl.gov/facilities/SNS/> and the High Flux Isotope Reactor (HFIR; <http://neutrons.ornl.gov/facilities/HFIR/>) Use of the neutron sources is available at no charge through a user proposal process.

#### NGEE-Arctic (Next Generation Ecosystem Experiments)

DOE supports process studies and modeling to assess carbon cycle dynamics in high-latitude terrestrial ecosystems. The NGEE-Arctic project focuses on permafrost ecology in a warming Arctic, and how associated changes in biogeochemical processes and vegetation dynamics will affect feedbacks to the climate system. Fundamental knowledge gained in these investigations will improve representation of ecosystem dynamics, subsurface biogeochemistry, and atmosphere processes in regional and global models, and improve predictions of climate change in tundra ecosystems. More information on the study and information for contacting NGEE-Arctic project staff to discuss collaborative research are described on the project web site (<http://ngee.ornl.gov/>).

#### NGEE-Tropics (Next Generation Ecosystem Experiments)

DOE supports process studies and modeling efforts to assess climate relevant feedbacks in tropical forested ecosystems. The NGEE-Tropics project focuses on understanding how carbon cycling in tropical forests will respond to changing temperature, precipitation, CO<sub>2</sub> concentrations, and/or disturbance. Gained knowledge will be used to develop process rich, trait-based models to improve the current generation of Earth system models. #### Spruce and Peatland Responses Under Climate and Environmental Change (SPRUCE)

DOE supports an experiment to assess the response of northern boreal and peatland ecosystems to increases in temperature and elevated atmospheric CO<sub>2</sub> concentrations. The SPRUCE experiment was established for a decade of whole-ecosystem warming at the Marcell Experimental Forest in northern Minnesota beginning in August 2015. More information on the study, a listing of currently funded collaborators, and the method for contacting SPRUCE project staff can be found online (<http://mnspruce.ornl.gov/>). Interested collaborators must discuss their potential research interests with project staff to avoid duplication of effort and to ensure available space within the SPRUCE footprint. SPRUCE is currently hosting an abundance of funded cooperative research efforts at this time. Persons interested in new collaborative measurements should contact project personnel to check on duplication of effort and the availability of space for any new research. ### Synchrotron Light Sources

DOE provides the scientific community access to several synchrotron light sources that are capable of providing structural and chemical information often unavailable with conventional sources of x-rays. DOE laboratories with Office of Science user facility synchrotrons include: Argonne National Laboratory (<http://www.aps.anl.gov/>); Brookhaven National Laboratory (<http://www.nsls.bnl.gov/>); Lawrence Berkeley National Laboratory (<http://www.als.lbl.gov/>); and Stanford Synchrotron Radiation Laboratory (<http://www-ssrl.slac.stanford.edu/index.html>). Use of the synchrotron light sources is available at no charge through a user proposal process.

### **Any Other Special Requirements:**

Applications that have been declined previously by this program are required to address within the Narrative Section major issues and concerns raised by previous reviews and to describe how the application was improved and updated since the original submission. All applicants must check “NEW” on the SF-424 R&R when submitting. Do not select Revised or Resubmission.

**All Lead PIs are required to attend the ESS Principal Investigators (PI) meeting** (generally a 2-day meeting) held in the Washington DC area in the spring of each year. Travel funds should be budgeted to allow at least the lead PI to attend this meeting.

### **A. TYPE OF AWARD INSTRUMENT**

DOE anticipates awarding grants under this FOA.

DOE encourages multi-institutional collaborations where appropriate. However, DOE will only fund such collaborations through a single consolidated proposal with subcontracts from the lead institution.

It is anticipated that up to \$5,000,000 from Environmental System Science (TES - \$2,000,000 and SBR - \$3,000,000) will be available for approximately 8 to 10 awards to be made in Fiscal Year 2016, contingent on the availability of appropriated funds. Applicants may request project support for up to three years with a total budget of up to \$600,000. Programmatic relevance and cost effectiveness are factors in evaluating all grant applications.

DOE is under no obligation to pay for any costs associated with preparation or submission of applications. DOE reserves the right to fund, in whole or in part, any, all, or none of the applications submitted in response to this FOA.

For grant awards, the value of, and funding for, a DOE/NNSA National Laboratory contractor, a non-DOE/NNSA FFRDC contractor, or another Federal agency's portion of the work will not be included in the award to the successful applicant. DOE will fund a DOE/NNSA National Laboratory contractor through the DOE field work authorization system or other appropriate process and will fund non-DOE/NNSA FFRDC contractors and other Federal agencies through an interagency agreement in accordance with the Economy Act, 31 U.S.C. 1535, or other statutory authority.

## **I. RESPONSIBILITY**

The successful prime applicant/awardee (lead organization) will be the responsible authority regarding the settlement and satisfaction of all contractual and administrative issues, including but not limited to, disputes and claims arising out of any agreement between the applicant and any team member, and/or subawardee.

If an award is made to another Federal agency or its FFRDC contractor, all Disputes and Claims will be resolved in accordance with the terms and conditions of the interagency agreement in consultation between DOE and the prime awardee.

DOE National Laboratories whose collaborating applications are considered for funding may be invited to submit a proposal in the Office of Science's PAMS website for the receipt of a Field Work Authorization. Other Federal agencies whose collaborating applications are considered for funding may be invited to submit a proposal in the Office of Science's PAMS website for the receipt of an Interagency Award.

This information should be followed by a clear and concise description of the objectives and technical approach of the proposed research. The pre-application may not exceed two pages, with a minimum text font size of 11 point and margins no smaller than one inch on all sides. Figures and references, if included, must fit within the two-page limit.

Those pre-applications that are encouraged will be used to help the Office of Science begin planning for the full application peer review process. The intent of the Office of Science in discouraging submission of certain full applications is to save the time and effort of applicants in preparing and submitting full applications not responsive to this funding opportunity announcement.

The Principal Investigator will be automatically notified when the pre-application is encouraged or discouraged. The DOE Office of Science Portfolio Analysis and Management System (PAMS) will send an email to the Principal Investigator from [PAMS.Autoreply@science.doe.gov](mailto:PAMS.Autoreply@science.doe.gov), and the status of the pre-application will be updated at the PAMS website <https://pamspublic.science.energy.gov/>. ### **A. CRITERIA**

#### **1. Initial Review Criteria**

Prior to a comprehensive merit evaluation, DOE will perform an initial review in accordance with 10 CFR 605.10(b) to determine that (1) the applicant is eligible for the award; (2) the information required by the FOA has been submitted; (3) all mandatory requirements are satisfied; (4) the proposed project is responsive to the objectives of the funding opportunity announcement, and (5) the proposed project is not duplicative of programmatic work. Applications that fail to pass the initial review will not be forwarded for merit review and will be eliminated from further consideration.

#### **2. Merit Review Criteria**

Applications will be subjected to scientific merit review (peer review) and will be evaluated against the following criteria, listed in descending order of importance as found in 10 CFR 605.10 (d), the Office of Science Financial Assistance Program Rule.

- Scientific and/or Technical Merit;
- Appropriateness of the Proposed Method or Approach;
- Competency of Applicant's Personnel and Adequacy of Proposed Resources; and
- Reasonableness and Appropriateness of the Proposed Budget.
- Data and Team Management

The evaluation process will include program policy factors such as the relevance of the proposed research to the terms of the FOA and the agency's programmatic needs. Note that external peer reviewers are selected with regard to both their scientific expertise and the absence of conflict-of-interest issues. Both Federal and non-Federal reviewers may be used, and submission of an application constitutes agreement that this is acceptable to the investigator(s) and the submitting institution.

The questions below are provided to the merit reviewers to elaborate the criteria established by regulation:

#### **SCIENTIFIC AND/OR TECHNICAL MERIT**

- What is the scientific innovation of proposed effort?
- How does the proposed work compare with other efforts in its field, both in terms of scientific and/or technical merit and originality?
- How might the results of the proposed work impact the direction, progress, and thinking in relevant scientific fields of research?
- What is the likelihood of achieving influential results to advance the field of research?

#### APPROPRIATENESS OF THE PROPOSED METHOD OR APPROACH

- Does the proposed effort employ innovative concepts or methods?
- How logical and feasible are the approaches?
- Are the conceptual framework, methods, and analyses well justified, adequately developed, and likely to meet the objectives and/or test the hypothesis?
- Does the applicant recognize significant potential problems and consider alternative strategies?
- Does the PI pose their research applications in the context of representing processes in a modeling context?

#### COMPETENCY OF APPLICANT'S PERSONNEL AND ADEQUACY OF PROPOSED RESOURCES

- Does the proposed work take advantage of unique facilities and/or capabilities?
- Are the environment and facilities adequate for performing the proposed effort?
- How well qualified is the team to carry out the proposed work?
- What is the past performance of the team?

#### REASONABLENESS AND APPROPRIATENESS OF THE PROPOSED BUDGET

- Are the proposed budget and staffing levels adequate to carry out the proposed work?
- Is the budget reasonable and appropriate for the scope?
- Are investments in new or enhanced research sites justified?

#### DATA AND TEAM MANAGEMENT

- Does the application present a management structure and mechanisms for integrating the research carried out between/among the collaborating investigators to produce the proposed results?
- Is there a Data Management Plan (DMP)? Does the proposed DMP describe whether and how data generated in the course of the proposed research will be shared and preserved, and does it describe how data sharing and preservation will enable validation of results, or how results could be validated if data are not shared or preserved?
- Does the proposed DMP describe the plan for making all research data displayed in publications resulting from the proposed research open, machine-readable, and digitally accessible to the public at the time of publication?



- Does the proposed DMP consult and reference available information about data management resources to be used in the course of the proposed research?

### **2. Selection**

### **3. Review of Risk**

<b>acquisition cost</b>	The cost of an asset, including the cost to put it in place. When used with equipment (capital expenditure), the term means the net invoice price of property or supplies including cost of modifications, attachments, accessories, or auxiliary apparatus necessary to make the property usable for the purpose for which it was acquired. Other charges, such as the cost of installation, transportation, taxes, duty, or protective in-transit insurance, are included or excluded from the unit acquisition cost in accordance with the recipient's regular accounting practices. It does not include costs for rental of property or alteration and rental of real property.
<b>administrative requirements</b>	The general business management practices that are common to the administration of all grants, such as financial accountability, reporting, equipment management, and retention of records.
<b>allocation</b>	The process of assigning costs to one or more cost objectives, in reasonable and realistic proportion to the benefit provided or other equitable relationship.
<b>allocability</b>	The principle which requires that an expense or service charged must directly benefit and be necessary for the performance of the project; when multiple projects are benefited reasonable proportions must be able to be assigned.
<b>allowable cost</b>	A cost incurred by a recipient that is: (1) reasonable for the performance of the award; (2) allocable; (3) in conformance with any limitations or exclusions set forth in the Federal cost principles applicable to the organization incurring the cost or in the award documents as to the type or amount of cost; (4) consistent with regulations, policies, and procedures of the recipient that are applied uniformly to both federally supported and other activities of the organization; (5) accorded consistent treatment as a direct or indirect cost; (6) determined in accordance with generally accepted accounting principles; and (7) not included as a cost in any other federally supported award (unless specifically authorized by statute).
<b>application</b>	A request for financial support of a project or activity submitted to DOE on specified forms and in accordance with DOE instructions. Also known as a proposal
<b>Appropriation Act</b>	The statute that provides the authority for Federal agencies to incur obligations to and make payments out of the U.S. treasury for specified purposes.
<b>approved budget</b>	The financial expenditure plan for the grant-supported project or activity, including revisions approved by DOE and permissible revisions made by the grantee. The approved budget consists of Federal (grant) funds and, if required by the terms and conditions of the award, non-Federal participation in the form of matching or cost sharing. The approved budget specified in the award documents may be shown in detailed budget categories or as total costs without a categorical breakout. Expenditures charged to an approved budget that consists of both Federal and non-Federal shares are deemed to be borne by the grantee in the same proportion as the percentage of Federal/non-Federal participation in the overall budget.
<b>assurance</b>	A certification by an applicant, normally included with the application or State plan, indicating that the entity is in compliance with, or that it will abide by, a particular requirement if awarded a Federal grant.
<b>authorized organizational representative award</b>	The individual, named by the applicant organization, who is authorized to act for the applicant and to assume the obligations imposed by the Federal laws, regulations, requirements, and conditions that apply to grant applications or grant awards. The provision of funds by DOE, based on an approved application and budget or progress report, to an organizational entity or an individual to carry out a project or activity.
<b>award documents</b>	The entirety of the documents describing the legal relationship between DOE and an awardee or recipient. The award documents include an Assistance Agreement and other

documents which may be incorporated by reference or as attachments to the Assistance Agreement. The award documents are the official, legally binding document, signed (or the electronic equivalent of signature) by a contracting officer that:

- notifies the recipient of the award of a grant;
- contains or references all the terms and conditions of the grant and Federal funding limits and obligations; and,
- provides the documentary basis for recording the obligation of Federal funds in the DOE accounting system.

<b>Bayh-Dole Act</b>	Law which encourages universities and researchers to develop their inventions into marketable products; formal citation is Section 6 of the Patent and Trademark Amendment of 1980, Pub. L 96-517
<b>budget</b>	An estimate of expenditures to be incurred in the performance of a proposed statement of work, or the financial plan or cost assessment for the grant proposal. The budget represents costs associated with project implementation.
<b>budget period</b>	The intervals of time (usually 12 months each) into which a project period is divided for budgetary and funding purposes.
<b>business officer</b>	The financial official of the grantee who has primary fiscal responsibility for the grant. Also known as authorized organizational representative.
<b>carryover</b>	Unobligated Federal funds remaining at the end of any budget period that, with the approval of the contracting officer or under an automatic authority, may be carried forward to another budget period to cover allowable costs of that budget period (whether as an offset or additional authorization). Obligated, but unliquidated, funds are not considered carryover.
<b>change in scope</b>	An activity whereby the objectives or specific aims identified in the approved grant application are significantly changed by the grantee after award. Contracting officer prior approval is required for a change in scope to be allowable under an award.
<b>closeout</b>	The process by which a Federal awarding agency determines that all applicable administrative actions and all required work under an award have been completed by the grantee and the Federal awarding agency.
<b>competitive segment</b>	The initial project period recommended for support or each extension of a project period resulting from a renewal award.
<b>conference (domestic or international)</b>	A symposium, seminar, workshop, or any other organized and formal meeting, whether conducted face-to-face or via the Internet, where individuals assemble (or meet virtually) to exchange information and views or explore or clarify a defined subject, problem, or area of knowledge, whether or not a published report results from such meeting.
<b>consortium or subaward agreement</b>	A formalized agreement whereby a research project is carried out by the grantee and one or more other organizations that are separate legal entities. Under the agreement, the grantee must perform a substantive role in the conduct of the planned research and not merely serve as a conduit of funds to another party or parties. These agreements typically involve a specific level of effort from the consortium organization's PD/PI and a categorical breakdown of costs, such as personnel, supplies, and other allowable expenses, including F&A costs. The relationship between the recipient and the collaborating organizations is considered a subaward relationship.
<b>consultant</b>	An individual who provides professional advice or services for a fee, but normally not as an employee of the engaging party. In unusual situations, an individual may be both a consultant and an employee of the same party, receiving compensation for some services as a consultant and for other work as a salaried employee. To prevent apparent or actual conflicts of interest, grantees and consultants must establish written guidelines indicating the conditions of payment of consulting fees. Consultants also include firms that provide professional advice or services.
<b>continuation application/award</b>	A financial assistance request (in the form of an application or progress report) or resulting award for a subsequent budget period within a previously approved project period for which a recipient does not have to compete with other applicants.
<b>contract</b>	An award instrument used to acquire from a non-federal party, by purchase, lease, or

	barter, property or services for the direct benefit or use of the Federal government. The same term may be used to describe a vendor relationship between a recipient and another party under a grant (to acquire routine goods and services); however, the recipient may use subaward to describe the contract under a grant relationship.
<b>Contract (or Grants Management) Officer</b>	A DOE official responsible for the business management aspects of grants and cooperative agreements, including review, negotiation, award, and administration, and for the interpretation of grants administration policies and provisions. COs and GMOs are delegated the authority to obligate DOE to the expenditure of funds and permit changes to approved projects on behalf of DOE.
<b>Contract (or Grants Management) Specialist</b>	A DOE staff member who works with a contract or grants management officer and is assigned the day-to-day management of a portfolio of grants and/or cooperative agreements. These activities include, but are not limited to, evaluating grant applications for administrative content and compliance with statutes, regulations, and guidelines; negotiating grants; providing consultation and technical assistance to grantees; and administering grants after award.
<b>cooperative agreement</b>	A type of financial assistance used when there will be substantial Federal scientific or programmatic involvement. Substantial involvement means that, after award, scientific or program staff will assist, guide, coordinate, or participate in project activities.
<b>cost principles</b>	The government-wide principles, issued by OMB (or, in the case of commercial organizations, the Federal Acquisition Regulation [48 CFR 21], or, in the case of hospitals, 45 CFR 74, Appendix E, "Principles For Determining Costs Applicable to Research and Development Under Grants and Contracts with Hospitals"), on allowability and unallowability of costs under federally sponsored agreements. As of December 26, 2014, the cost principles will be consolidated in 2 CFR 200.
<b>cost sharing</b>	The portion of the costs of a project or program not borne by the sponsor; these could be grantee contributions or third-party in-kind contributions; costs used to satisfy cost sharing requirements are subject to the same policies governing allowability as other costs of the project. Research grants are generally not subject to cost sharing requirements. Also known as matching.
<b>deadline</b>	The published date and/or time that a grant application is to be either postmarked/mailed or electronically submitted to the funding agency.
<b>debarment and suspension</b>	The actions taken by a debarment official in accordance with OMB guidance at 2 CFR 180, "Non-procurement Debarment and Suspension," to exclude a person or organization from participating in grants and other non-procurement awards government-wide. If debarred or suspended, the person or organization may not receive financial assistance (under a grant, cooperative agreement, or subaward, or contract under a grant) for a specified period of time. Debarments and suspensions carried out pursuant to 2 CFR 376 are distinct from post-award suspension action by an awarding agency.
<b>direct costs</b>	Costs that can be identified specifically with a particular sponsored project, an instructional activity, or any other institutional activity, or that can be directly assigned to such activities relatively easily with a high degree of accuracy.
<b>disallowance</b>	A charge to a grant that the Federal awarding agency determines to be unallowable in accordance with the applicable Federal cost principles or other terms and conditions contained in the award.
<b>domestic organization</b>	A public (including a State or other governmental agency) or private non-profit or for-profit organization that is located in the United States or its territories, is subject to U.S. laws, and assumes legal and financial accountability for awarded funds and for the performance of the grant-supported activities.
<b>DUNS number</b>	A nine-digit number established and assigned by Dun and Bradstreet to uniquely identify a business entity.
<b>effort</b>	The amount of time, usually expressed as a percentage of the total, which a faculty member or other employee spends on a sponsored project. No one is allowed to spend more than 100% total commitment on all academic activities, including grant-sponsored research, university-sponsored research, teaching, administration, advising and other

<b>equipment</b>	contracted duties. Effort is indicated on the budget in units of person-months. An article of tangible nonexpendable personal property that has a useful life of more than 1 year and an acquisition cost per unit that equals or exceeds \$5,000 or the capitalization threshold established by the organization, whichever is less.
<b>expanded authorities</b>	Authorization to grantees under certain research grant mechanisms which waives the requirement for prior agency approval for specified actions related to awards. Example: 90-day preaward spending authority, no cost extensions for up to one additional year, and automatic carryover of unobligated funds from one budget period to the next. The expanded authorities are now contained in the standard terms and conditions for most research grants.
<b>expiration date</b>	Generally, the date signifying the end of the current project period, after which the grantee is not authorized to obligate grant funds.
<b>facilities and administrative costs</b>	Costs that are incurred by a grantee for common or joint objectives and that, therefore, cannot be identified specifically with a particular project or program. These costs also are known as indirect costs.
<b>Federal Financial Report</b>	Submitted on Standard Form (SF) 425, to indicate the status of awarded funds for the period covered. Frequency of reporting is specified in the Reporting Checklist provided as part of the award documents. Replaces the SF-269 Financial Status Report (FSR)
<b>financial assistance</b>	Transfer by DOE of money or property to an eligible entity to support or stimulate a public purpose authorized by statute.
<b>Financial Status Report</b>	See Federal Financial Report.
<b>foreign travel</b>	Foreign travel includes travel outside of the United States and its territories and possessions (Guam, American Samoa, Puerto Rico, the Virgin Islands, and the Canal Zone) and Canada. A trip is considered foreign travel for all legs of the itinerary if the traveler does not return to his or her post prior to departure for a foreign destination. Costs for foreign travel may be restricted by the language of a Funding Opportunity Announcement.
<b>funding opportunity announcement</b>	A publicly available document by which a Federal Agency makes known its intentions to award discretionary grants or cooperative agreements, usually as a result of competition for funds. Funding opportunity announcements may be known as program announcements, requests for applications, notices of funding availability, solicitations, or other names depending on the Agency and type of program. Funding opportunity announcements can be found at <a href="http://Grants.gov/FIND">Grants.gov/FIND</a> . An FOA may also be known as a solicitation.
<b>grant</b>	A financial assistance mechanism providing money, property, or both to an eligible entity to carry out an approved project or activity. A grant is used whenever DOE anticipates no substantial programmatic involvement with the recipient during performance of the financially assisted activities.
<b>grant-supported project or activity</b>	Those activities specified or described in a grant application or in a subsequent submission that are approved by DOE for funding, regardless of whether Federal funding constitutes all or only a portion of the financial support necessary to carry them out.
<b>grantee</b>	The organization or individual awarded a grant or cooperative agreement by DOE that is responsible and accountable for the use of the funds provided and for the performance of the grant-supported project or activity. The grantee is the entire legal entity even if a particular component is designated in award documents. The grantee is legally responsible and accountable to DOE for the performance and financial aspects of the grant-supported project or activity. Also known as awardee or recipient.
<b>Grants.gov</b>	Grants.gov ( <a href="http://www.grants.gov/">http://www.grants.gov/</a> ) has been designated by the Office of Management and Budget as the single access point for all grant programs offered by 26 Federal grant-making agencies. It provides a single interface for agencies to announce their grant opportunities and for all applicants to find and apply for those opportunities.
<b>indirect costs</b>	See facilities and administrative costs definition.
<b>institutional base salary</b>	The annual compensation paid by an organization for an employee's appointment, whether that individual's time is spent on research, teaching, patient care, or other

<b>matching or cost sharing</b>	<p>activities. Base salary excludes any income that an individual may be permitted to earn outside of duties for the applicant/grantee organization. Base salary may not be increased as a result of replacing organizational salary funds with grant funds. The value of third-party in-kind contributions and the portion of the costs of a federally assisted project or program not borne by the Federal government. Matching or cost sharing may be required by statute or program regulation. Costs used to satisfy matching or cost-sharing requirements are subject to the same policies governing allowability as other costs under the approved budget.</p>
<b>merit (or peer) review</b>	<p>The process that involves the consistent application of standards and procedures that produce fair, equitable, and objective examinations of applications based on an evaluation of scientific or technical merit or other relevant aspects of the application. The review is performed by experts (reviewers) in the field of endeavor for which support is requested. Merit review is intended to provide guidance and to the DOE individuals responsible for making award decisions.</p>
<b>monitoring</b>	<p>A process whereby the programmatic and business management performance aspects of a grant are assessed by reviewing information gathered from various required reports, audits, site visits, and other sources.</p>
<b>no-cost extension</b>	<p>An extension of time to a project period and/or budget period to complete the work of the grant under that period, without additional Federal funds or competition.</p>
<b>non-Federal share obligations</b>	<p>When cost sharing or matching is required as a condition of an award, the portion of allowable project/program costs not borne by the Federal government. The amounts for which the recipient has made binding commitments for orders placed for property and services, contracts and subawards, and similar transactions during a funding period that will require payment during the same or a future period.</p>
<b>OMB Circulars</b>	<p>Government-wide guidance issued to Heads of Federal agencies by the Director of OMB. OMB Circulars directly pertinent to grants include the following:</p> <ul style="list-style-type: none"> <li>• cost principles (OMB Circular A-21, OMB Circular A-87, and OMB Circular A-122);</li> <li>• uniform administrative requirements (OMB Circular A-102 and OMB Circular A-110);</li> <li>• audit requirements for non-profit organizations (OMB Circular A-133).</li> </ul> <p>Some (but not all) of these OMB Circulars have been reissued in Title 2 of the Code of Federal Regulations. DOE administrative regulations are located in Title 10 of the Code of Federal Regulations.</p>
<b>Other Significant Contributors</b>	<p>Individuals who have committed to contribute to the scientific development or execution of the project, but are not committing any specified measurable effort (i.e., person months) to the project. These individuals are typically presented at “effort of zero person months” or “as needed.” Individuals with measurable effort may not be listed as Other Significant Contributors (OSCs). Consultants should be included if they meet this definition.</p>
<b>participant</b>	<p>Program participants are the recipients of service or training provided at a workshop, conference, seminar, symposium or other short-term instructional or information-sharing activity funded by an external grant or award, or the training beneficiaries of the project or program funded by an external grant or award. A participant is not involved in providing any deliverable to the grantee or a third party or would not be terminated or replaced for failure to perform.</p>
<b>participant costs</b>	<p>Costs used to pay program participants small stipends and reimbursement of travel costs or other out-of-pocket costs incurred to support attendance at a workshop, conference, seminar, symposium, or other short-term training or information-sharing activity.</p>
<b>person months</b>	<p>The metric for expressing the effort (amount of time) PD/PI(s), faculty and other senior/key personnel devote to a specific project. The effort is based on the type of appointment of the individual with the organization; e.g., calendar year, academic year, and/or summer term; and the organization’s definition of such. For instance, some institutions define the academic year as a 9-month appointment while others define it as</p>



<b>pre-application or pre-proposal</b>	<p>a 10-month appointment.</p> <p>A brief outline or narrative of proposed work and sometimes budget, for informal review by a sponsor to determine whether a full application should be submitted. Three predominant reasons for requiring submission of a preliminary pre-application are:</p> <ul style="list-style-type: none"> <li>• Reduce the applicant’s unnecessary effort in proposal preparation when the chance of success is very small. This is particularly true of exploratory initiatives where the community senses that a major new direction is being identified, or competitions that will result in a small number of actual awards.</li> <li>• Increase the overall quality of the full submission.</li> <li>• Distill the number of applications that will be submitted to the agency and the number of anticipated reviewers needed to review.</li> </ul>
<b>pre-award costs</b>	Any cost incurred prior to the beginning date of the project period or the initial budget period of a competitive segment (under a multi-year award), in anticipation of the award and at the applicant’s own risk, for otherwise allowable costs.
<b>prior approval</b>	Written approval from the designated contracting officer required for specified post-award changes in the approved project or budget. Such approval must be obtained before undertaking the proposed activity or spending DOE funds
<b>Program Director/ Principal Investigator</b>	The individual(s) designated by the applicant organization to have the appropriate level of authority and responsibility to direct the project or program to be supported by the award. The applicant organization may designate multiple individuals as program directors/principal investigators (PD/PIs) who share the authority and responsibility for leading and directing the project, intellectually and logistically. When multiple PD/PIs are named, each is responsible and accountable to the applicant organization, or as appropriate, to a collaborating organization for the proper conduct of the project or program including the submission of all required reports. The presence of more than one PD/PI on an application or award diminishes neither the responsibility nor the accountability of any individual PD/PI.
<b>program income</b>	Program income is gross income earned by a research grant recipient from the activities, part or all of which are borne as a direct cost by the grant. Examples are fees for services performed under the grant, rental or usage fees charged for use of equipment purchased with grant funds, third party patient reimbursements for hospital or medical services paid from the grant, funds generated by the sale of commodities, such as cell lines or research animals developed from or paid for from the grant, and patent or copyright royalties.
<b>Program Manager</b>	The DOE official responsible for the programmatic, scientific, and/or technical aspects of a grant. The same role is filled by Program Directors, Program Officers, or Project Directors at other Federal agencies.
<b>progress report</b>	Periodic, frequently annual, report submitted by the grantee and used by DOE to assess progress and to determine whether to provide funding for the budget period subsequent to that covered by the report.
<b>project/performance site</b>	Location(s) of where the work described in the research plan will be conducted.
<b>project period</b>	The total time for which Federal support of a project has been programmatically approved as shown in the award documents; however, it does not constitute a commitment by the Federal government to fund the entire period. The total project period comprises the initial competitive segment, any subsequent competitive segments resulting from a renewal award(s), and extensions.
<b>proposal re-budgeting</b>	See application. Reallocation of funds available for spending between budget categories to allow best use of funds to accomplish the project goals.
<b>recipient</b>	The organizational entity or individual receiving a grant or cooperative agreement.
<b>renewal application</b>	An application requesting additional funding for a period subsequent to that provided by a current award. Renewal applications compete for funds with all other peer reviewed applications and must be developed as fully as though the applicant is applying for the first time.

<b>research</b>	A systematic, intensive study intended to increase knowledge or understanding of the subject studied, a systematic study specifically directed toward applying new knowledge to meet a recognized need, or a systematic application of knowledge to the production of useful materials, devices, and systems or methods, including design, development, and improvement of prototypes and new processes to meet specific requirements. Also termed “research and development.”
<b>research misconduct</b>	Fabrication, falsification, plagiarism, or other practices that seriously deviate from those that are commonly accepted within the scientific community in proposing, performing, or reporting research, or in reporting research results; does not include honest error or honest differences in interpretations or judgments of data.
<b>SAM.gov</b>	The System for Award Management (SAM) is the Government-wide system that consolidated the Central Contractor Registration (CCR), the Excluded Parties List System (EPLS), the Online Representations and Certifications Application (ORCA), and the Federal Agency Registration (FedReg).
<b>scope of work</b>	The aims, objectives, and purposes of a grant; as well as the methodology, approach, analyses or other activities; and the tools, technologies, and timeframes needed to meet the grant’s objectives. This includes the research or training plan included with the original grant application, along with any approved modifications.
<b>Senior/Key Personnel</b>	The PD/PI and other individuals who contribute to the scientific development or execution of a project in a substantive, measurable way, whether or not they receive salaries or compensation under the grant. Typically these individuals have doctoral or other professional degrees, although individuals at the masters or baccalaureate level may be considered senior/key personnel if their involvement meets this definition. Consultants and those with a postdoctoral role also may be considered senior/key personnel if they meet this definition. “Zero percent” effort or “as needed” is not an acceptable level of involvement for Senior/Key Personnel.
<b>significant rebudgeting</b>	A threshold that is reached when expenditures in a single direct cost budget category deviate (increase or decrease) from the categorical commitment level established for the budget period by more than 25 percent of the total costs awarded. Significant rebudgeting is one indicator of change in scope.
<b>small business concern</b>	A business that is independently owned and operated and not dominant in its field of operation; has its principal place of business in the United States and is organized for profit; is at least 51 percent owned, or in the case of a publicly owned business, at least 51 percent of its voting stock is owned by U.S. citizens or lawfully admitted permanent resident aliens; has, including its affiliates, not more than 500 employees; and meets other regulatory requirements established by the SBA at 13 CFR 121.
<b>solicitation subaward</b>	See Funding Opportunity Announcement A legal instrument by which a recipient provides funds (or property in lieu of funds) to an eligible subrecipient (or a lower-tier transaction) to perform a substantive portion of the grant-supported program or project. The term includes such financial assistance when provided by any legal agreement (even if the agreement is called a contract) but does not include any form of assistance which is excluded from the definition of a grant, including the recipient’s procurement of property or services needed to carry out the project or program. The term includes consortium agreements.
<b>subrecipient</b>	A party that receives a subaward from a recipient or another subrecipient under a Federal financial assistance award and is accountable to the recipient or subrecipient for the use of the Federal funds provided by the subaward.
<b>supplement</b>	A request for an increase in support during a current budget period for expansion of the project’s scope or to meet increased costs unforeseen at the time of the new or renewal application. A supplement may increase support for future years in addition to the current year. Supplements require applications and are subject to administrative and merit review.
<b>terms and conditions of award</b>	All legal requirements imposed on a grant by DOE, whether based on statute, regulation, policy, or other document referenced in the grant award, or specified by the grant award document itself. The award documents may include both standard and

	special conditions that are considered necessary to attain the grant’s objectives, facilitate post-award administration of the grant, conserve grant funds, or otherwise protect the Federal government’s interests.
<b>unallowable costs</b>	Specific categories of costs that cannot be charged, directly or indirectly, to federally sponsored agreements in accordance with federal regulations or the terms and conditions of the award.
<b>unliquidated obligation</b>	For reports prepared on a cash basis, the amount of obligations incurred by the recipient that has not been paid; or For reports prepared on an accrued expenditure basis, the amount of obligations incurred by the recipient for which an outlay has not been recorded.
<b>unobligated balance</b>	The portion of the funds authorized by the Federal agency for expenditure by the recipient that has not been obligated by the recipient.
<b>Validate</b>	In the context of the data management plan requirements, <i>validate</i> means to support, corroborate, verify, or otherwise determine the legitimacy of the research findings. Validation of research findings could be accomplished by reproducing the original experiment or analyses, comparing and contrasting the results against those of a news experiment or analyses, or by some other means.
